WORKFIRST NEW JERSEY SERVICES  
TO  
SUITS FOR SUCCESS, INC.  
JULY 1, 2016 TO JUNE 30, 2017  
(\$160,000.00)

WHEREAS, by way of Resolution No. 549-9-2016, this Board awarded unallocated funds from the New Jersey Department of Workforce Development for Workfirst New Jersey services to social services providers; and

WHEREAS, these contract awards were not subject to "Pay to Play" requirements as they emanated from a fair and open competitive process pursuant to N.J.S.A. 40A:11-4.1; and

WHEREAS, the Director of the Hudson County Department of Family Services will have the authority to adjust funding levels during the contract period for various services within approved overall agency allocations, based upon customer utilization of these services; and

WHEREAS, it is recommended that the unallocated funds be allocated as follows consistent with the Workfirst New Jersey regulations in the stated amounts for the period of July 1, 2016 to June 30, 2017:

WHEREAS, the funds to be allocated for these services to Suits for Success, Inc. is in the amount of **ONE HUNDRED SIXTY THOUSAND DOLLARS 00/100 (\$160,000.00)**; and

WHEREAS, Suits for Success, Inc., 121-125 Newark Avenue, Jersey City, New Jersey 07305 is a not-for-profit entity that has provided these social services to the County in the past; and

WHEREAS, such services are not subject to "Pay to Play" at N.J.S.A. 19-44A-2014 as the vendor is a not-for-profit entity providing social services; and

WHEREAS, the Director of Finance and Administration has certified in writing that funds are available for the purpose of this Resolution in Account No. 02-213-40-740-16.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Hudson that:

1. The aforesaid recitals are incorporated therein as though fully set forth at length.
2. The Board hereby authorizes the County Executive, Thomas A. DeGise, or County Administrator, Abraham Antun, or Deputy County Administrator, David B. Drumeler, or their lawfully appointed designee, to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of this Resolution.
